10. CONSTRUCTION MANAGER AT RISK SELECTION AND AGREEMENT: E-37 ELEMENTARY

A new elementary school designated E-37, located in Cary, is proposed for funding in CIP 2013. Pursuant to the professional services selection procedures (Policy 7265), Clancy & Theys Construction is recommended for construction of the E-37 elementary school. The form of agreement is the standard form approved by the Board attorney. Fiscal Implications: Funding, in the amount of \$700,000, has been requested from the Wake County Board of Commissioners (BOC). The project budget includes pre-construction compensation for the Construction Manager of \$75,000. This contract only authorizes pre-construction work. Funding from CIP 2013 will be needed to fund construction. Savings: Approximately \$350,000 on overhead expenses. Recommendation for Action: Board approval contingent upon appropriation of funding by the BOC.

11. CONSTRUCTION MANAGER AT RISK SELECTION AND AGREEMENT: E-38 ELEMENTARY

A new elementary school designated E-38, located in Cary, is proposed for funding in CIP 2013. Pursuant to the professional services selection procedures (Policy 7265), Metcon Construction, Inc., is recommended for construction of the E-38 elementary school. The form of agreement for is the standard form approved by the Board attorney. Fiscal Implications: Funding, in the amount of \$700,000, has been requested from the Wake County Board of Commissioners (BOC). The project budget includes pre-construction compensation for the Construction Manager of \$75,000. This contract only authorizes pre-construction work. Funding from CIP 2013 will be

needed to fund construction. Savings: Approximately \$350,000 in overhead expense. Recommendation for Action: Board approval contingent upon appropriation of funding by the BOC.

12. CONSTRUCTION MANAGER AT RISK SELECTION AND AGREEMENT: M-13 MIDDLE

A new middle school designated M-13, located in Raleigh, is proposed for funding in CIP 2013. Pursuant to the professional services selection procedures (Policy 7265), Barnhill Contracting Company is recommended for construction of the M-13 middle school. The form of agreement is the standard form approved by the Board attorney. Fiscal Implications: Funding, in the amount of \$1,000,000, has been requested from the Wake County Board of Commissioners (BOC). The project budget includes pre-construction compensation for the Construction Manager of \$125,000. This contract only authorizes pre-construction work. Funding from CIP 2013 will be needed to fund construction. Savings: Approximately \$900,000 in overhead expense. Recommendation for Action: Board approval contingent upon appropriation of funding by the BOC.

SCHOOL PERFORMANCE

13. TRIANGLE DEVELOPMENTAL SERVICES, PLLC

Triangle Developmental Services, PLLC will provide Occupational Therapy Services to identified students with disabilities. Services provided by Triangle Developmental Services will help to meet caseload requirements, as established by the North Carolina Department of Public Instruction, as well as provide coverage for positions currently vacant. The total contract amount is \$115,500. Fiscal Implications: Funding in the Special Education Services' budget in the amount of \$115,500 is to be used to pay the cost of these services. Savings: N/A. Recommendation for Action: Board approval is requested.

15. NAME FOR NEW HIGH SCHOOL IN CARY (H-7)

On or about December 19, 2008, the Board of Education acquired 88.09 acres for use as a high school in the H-7 target area. The site was master planned together with the adjacent Town of Cary park site. Naming of the new high school facility is now requested.

At the Facilities Committee meeting on December 11, 2013, the following names were proposed for consideration: (1) Green Level High, (2) White Oak High, (3) Roberts Road High, (4) Southwest Cary High, and (5) Anderson Ridge High. The Facilities Committee considered the naming options and voted to recommend Green Level High to the Board for its approval. Green Level High was proposed because of the site's geographic location in proximity to the Green Level community in accordance with Board Policy 2570. Name selection of Green Level High is

recommended. Fiscal Implications: None. Savings: Not applicable. Recommendation for Action: Board approval is requested.

16. NAME FOR NEW MIDDLE SCHOOL IN NORTHWESTERN RALEIGH (M-8)

On September 20, 2006, the Board of Education acquired 33.91 acres for use as an elementary school in the E-24 target area. When a suitable middle school site in the vicinity could not be found, the Board approved reassigning the elementary school site for use as a middle school, the target area designation was changed from E-24 to M-8, and a new E-24 elementary school site was acquired. The school is currently in design for construction in CIP 2013. Naming of the new middle school facility is now requested.

At the Facilities Committee meeting on December 11, 2013, the following names were proposed for consideration (1) Pine Hollow Middle, (2) Sycamore Creek Middle (3) Bartram Place Middle, (4) North Leesville Middle, and (5) Sorrells Ridge Middle. The Facilities Committee considered the naming options and voted to recommend Pine Hollow Middle to the Board for its approval. Pine Hollow Middle was proposed because of the site's natural features in accordance with Board Policy 2570. Name selection of Pine Hollow Middle is recommended. Fiscal Implications: None. Savings: Not applicable. Recommendation for Action: Board approval is requested.
