10. RENEWAL OF IBM PASSPORT ADVANTAGE AGREEMENT

This renewal is for maintenance and support of Lotus and Tivoli software products used by the district. Renewing support allows access to latest versions and/or releases as well as technical support. Last year's renewal was \$98,826.69. This year three Tivoli EndPoint Manager line items related to the purchase of IBM's BigFix Solution have been added. Term for these line items is prorated to co-term with existing renewal date. Total required to renew coverage for all items through 7/31/14 is \$189,398.51. Fiscal Implications: Total amount of renewal is \$189,398.51. Funding is available in the current Technology Services operating budget. Savings: Not applicable. Recommendation for Action: Staff is requesting Board approval of renewal.

11. LAPTOP COMPUTER INSURANCE FUNDS

Net Changes

Prior to fiscal year 2003-04, Wake County Public School System collected a \$25 fee from schools, departments, or employees utilizing system-owned laptop computers in areas other than their duty station. This fee reduced the employee deductible for stolen or vandalized laptop computers from \$2,000 to \$100 and the funds generated through the program replaced laptop computers if a loss occurred due to theft or vandalism. Due to the amount of funds available in the program, Wake County Public School System no longer collects the fee. A balance of \$8,014.14 remains in reserved fund balance. Average loss amount over past 4 years is less than \$5,000 with highest year losses of \$6,593.62. Fiscal Implications: This request is to appropriate \$6,000 of reserved fund balance for the current year. Savings: N/A. Recommendation for Action: Board approval requested.

12. CONTRACT EXTENSION: RECYCLING SERVICES FOR CNS

Staff requests Board approval to extend for one year a contract for recycling services with Grime Control Cleaning Service in the amount of \$343,500. The bid solicitation in 2010 included an initial term of one year with option to extend for three additional years. The unit prices are the same as last year. Recycling services will include recycling of polystyrene #6 (school lunch trays), commingled plastic bottles, aluminum beverage containers, #10 tin cans, and commingled mixed paper. Fiscal Implications: Funding is available from the 2013-2014 current expense budget. Savings: None. Recommendation for Action: Board approval is requested.

13. CONTRACT EXTENSION: FOOD SERVICE SANITATION SYSTEM SERVICES FOR CNS

Staff requests Board approval to extend for one year a contract for food service sanitation system services with Sanitech Systems Inc., in the amount of \$170,000. The bid solicitation in 2011 included an initial term of one year with option to extend for three additional years. The unit prices are the same as last year. A complete food service sanitation system will include service and training to school cafeteria employees and premeasured concentrated detergents, dispensing bottles, and related materials. Fiscal Implications: Funding is available from the 2013-2014 current expense budget. Savings: None. Recommendation for Action: Board approval is requested.
