FACILITIES

1. Acquisition and Development Agreement – New Panther High Site

The Wake County Board of Education approved of an Offer to Purchase Contract with Panther Creek Associates to acquire approximately 71.2 acres of land for a new high school to open in 2006. Condition of the contract requires a formal agreement with the Town of Cary to provide one third of the purchase price, construct public utilities, and a roadway system adjoining the site. Board may incur utility construction costs not to exceed \$200,000 and road construction costs not to exceed \$100.00 per foot. Board pays two thirds of the land cost.

2. Option Agreement - Middle Creek High, Elementary, Community Park and Affordable Housing

In April1999, The Wake County Board of Education acquired approximately 108 acres of land from a larger tract of approximately 320 acres at the current location for the Middle Creek High School and Elementary School. The overall transaction was an acquisition by the Town of Cary of approximately 100 acres and an acquisition of the remaining property of approximately 112 acres by a private developer Optimist Farm Ventures. A requirement by the Wake County Board of Education and the Town of Cary is to make available residential property adjacent to the Middle Creek Elementary School and in close proximity to the Middle Creek High School. The developer, Optimist Farm Ventures is to set aside 5 _ acres of land between the high school and the elementary school and develop 40 – 50 affordable housing units that would first be offered to teachers in the Wake County Public School System. The WCBOE required the developer an option to reacquire the 5 _ acres of land if the developer did not construct the affordable housing units. The start of construction would be within three years from the acquisition of the property April 1999. If construction fails the Board of Education has the right to exercise an option to acquire the property at a fixed price of \$15,865 per acre plus 8% interest from April 1999.

FACILITIES

1. Schedule Modification: Northwoods Elementary

PLAN 2000 includes a project to provide building systems replacement for Northwoods Elementary. A future renovation is also being planned for PLAN 2004 to modernize all classrooms. Staff recommended that the future capital improvement project be merged with the current project during the design phase. The total current project budget is \$2,991,600 as provided in the PLAN 2000 School Building Program. Additional funds of \$1.2 million are needed for Phase 1 code compliance, ADA improvements to the restrooms and roof replacement. Phase 2 will require additional funds of \$1.6 million for work planned to be bid as an added alternate with funding contingent upon passage of the PLAN 2004 bond program. Cedar Fork Elementary will be utilized in 2004-2005 as swing space while this work is being accomplished. *Students will move to Cedar Forks 2004-2005 while school is being renovated.*

- Phase 1 to include HVAC, electrical system, fire alarm, sprinklers, ceiling, lights, flooring, asbestos removal, new roof for the 1994 wing, site work, and ADA accessibility. The base bid \$4.2 million.
- Phase 2 to include windows, ADA accessible doors, technology, casework, furniture and remaining finishes. To add this alternate will cost \$1.6 million.
- *Total project cost is \$5.8 million.*

PROGRAM

1. No Child Left Behind Update (Exhibit D)

Recent information and decisions on the No Child Left Behind federal legislation was brought to the Board concerning the Title I programs and our accountability systems. The presentation outlined implications in the three areas: (1) Title I programs, (2) Accountability, and (3) Communication. A portion of Title I funds will be set aside to prepare for the likelihood that some schools do not meet the new NCLB standards.

1. Termination of Electrical Contract: Farmington Woods Addition and Renovations

M.C. Electric, Inc., the electrical contractor for the Farmington Wood addition and renovations project had defaulted on the project. Staff recommended authorization for the Superintendent or his designee to (1) terminated the contract; (2) retain a contractor to provide interim electrical contracting services for the project; and (3) begin negotiations with M.C. Electric Inc.'s surety for the completion of the project. All potential claims and additional costs will be forwarded to the contractor's surety company.
