# 6. RECOGNITION OF THE FALL SPORTS SEASON ATHLETIC TEAM STATE CHAMPIONS

#### 9. WAKE UP AND READ COMMUNITY COLLABORATION

Sherri Miller, Director of Literacy, introduced Carolyn Merrifield from Reach Out and Read, Hardin Englehart from Marbles Kids Museum, and Julie Crain from Wake Education Partnership. A brief history of Wake Up and Read Community Collaborative was shared. Ms. Miller shared that funding has been received from various community organizations and local Businesses.

The Collaborative is developing an ongoing community awareness campaign which will begin soon with a book drive. A comprehensive plan is being created for increasing the numbers of children that are read to daily. The Collaborative wants to increase parental education around literacy and provide books and other literacy opportunities for low income preschoolers and families. The Collaborative is currently reviewing the research behind how to reduce summer reading loss.

Resources that have been created and that are being worked on to provide to the community were shared with the Board as well as sharing the Wake Up and Read mascot, Ruben the Rooster. The student that selected the name of the mascot, Ruben De La Cruz, a third grade student at Briarcliff was acknowledged and presented with a Wake Up and Read t-shirt, passes for free admission to Marbles Kids Museum, and books.

Dawn Dawson, Senior Director for the Office of Early Learning shared the upcoming book drive theme: 40,000 books, 4 weeks, 4 our kids, 4 our community. Partners within the community will be joining in the focus on literacy targeting school-age and birth to age five. The book drive will be held March 2<sup>nd</sup> - 29<sup>th</sup>, with a kickoff event at Barnes and Noble at Brier Creek on March 2<sup>nd</sup> from 12:00 p.m. – 3:00 p.m. Drop off sites for the books will be listed on the Wake Up and Read website.

Board members began the book drive by donating books. Chairwoman Kushner encouraged the public to follow the example and accept the challenge of assisting in collecting 40,000 books.

# 22. BOARD POLICY 6011: ENTRANCE TO THE WAKE COUNTY PUBLIC SCHOOL SYSTEM

Revised; First Reading

Laura Evans, Senior Director of Student Assignment shared that the revisions to the policy were reviewed by the Superintendent's Leadership Team on 1/13/14 and was presented at the Policy Committee meeting on 2/6/14. At the Policy Committee meeting, there was a minor change in 6011.7B, the very last sentence should read, "to enroll in kindergarten a student must meet the age requirement set forth above in this policy." Jim Martin made a motion to approve the revised policy with the correction on first reading. The motion was seconded by Monika Johnson Hostler. The Board voted unanimously to approve the motion.

#### 23. BOARD POLICY 6201: SCHOOL ADMISSIONS

Revised; First Reading

Laura Evans, Senior Director of Student Assignment shared that the revisions to this policy were reviewed by the Superintendent's Leadership Team on 1/13/14 and was presented at the Policy Committee on 2/6/14. At the Policy Committee meeting, there was a minor change in 6201.1D, it should read, "long term suspension is suspension for a period of time in excess of ten consecutive school days." Jim Martin made a motion to approve the revised policy with the correction on first reading. The motion was seconded by Bill Fletcher. The Board voted unanimously to approve the motion.
