Chair's Comments

Chairwoman Kushner delivered comments related to the Mix 101.5 school choir competition where two Wake County Public Schools won; Martin Middle School for Division I and Sanderson High School for Division II, wishing retiring Principal, William Crockett all the best as he retires from Athens Drive High School, thanking the Greater Raleigh Chamber of Commerce for hosting a wonderful holiday reception, congratulating Enloe High School for raising over \$62,000 for the non-profit organization Safe Child, and announcing that this Thursday will be the final meeting of the Knightdale Educational Work Group

Superintendent's Comments

Dr. Merrill delivered comments related to the National Board for Professional Teaching Standards announcing that Wake County Public Schools has held on to its number one status regarding the number of National Board Certified teachers, the fund raiser at Enloe High School of \$62,000 is possibly a record for fund raising in Wake County, Sanderson High School students bringing in 224,483 pounds of food for the Food Bank of Central and Eastern North Carolina, Sanderson High School Choral leader, Marshall Butler winning the Laura Hoggard Award from the North Carolina Chapter of the American Choral Director's Association becoming the first high school director chosen and the first African-American chosen for the award, Wakefield High School winning a \$25,000 grant from State Farm Insurance where students participated in a national campaign called "Celebrate My Drive".

The motion was seconded by Susan P. Evans. The Board voted unanimously to approve the motion.
