Administration's Proposed 2013-14 School Assignment Plan Selection Priorities Update

1) First Transfer Application Period:

- First Transfer Priorities:

Priority 1: Incoming K, 6th, and 9th siblings of current non-base students wanting assignment to the same school if you chose this as your only choice and the request is made during ~~the school selection~~ First Transfer Application period (guaranteed)

Priority 2: "Stay where you start" – Existing students requesting grandfathering when they have been assigned to a new school if you make this request during the school selection period (guaranteed). Parent must provide transportation

Priority 3: Students requesting assignment for K to the same school where they attended preschool if their preschool was not their base school

Priority 4: Students attending an elementary school whose base middle school is not a calendar match and who select a middle school that continues their elementary school calendar

Priority 5: Students requesting a calendar to match the calendar of a sibling for grades K – 8.

Priority 6: Students whose base school is severely overcrowded and select a school that is not overcrowded as their first choice

Priority 7: Students rising into sixth or ninth grade requesting their choice plan feeder pattern middle or high school as their first choice school

Priority 8: Non-entry grade siblings of current students whose first choice school is their sibling's school

Middle School Calendar Options Update**

Middle School Calendar Options are based primarily on the 2011-12 calendar options. The calendar options are by node. Staff recommends the following calendar option changes as a result of base assignment changes:

Administration's Proposed 2013-14 School Assignment Plan Updates from the Board of Education Work Session on December 4, 2012

The Board agreed to reject the administration's proposal for middle school calendar options for the 2013-14 school assignment plan. They directed staff to reinstate the 2011-12 middle school calendar options for the remainder of the 2012-13 school year and for the 2013-14 school year, with minor adjustments related to base node changes. Staff will bring these minor adjustments to the Board at their work session on December 11, 2012.

The Board affirmed the elementary calendar option recommendations from staff with the following adjustments:

Node 632.0 will continue to have Oak Grove ES as their year-round calendar option

The following nodes will continue to have Durant Road ES as their year-round calendar option (274, 288.1, 288.4, 288.6, 289.1, 289.2, 624.0, 627.0, 630.0, 669.0, 680.0) and (273.4, 273.5, 273.6, 273.7, 273.8, 273.9)

The Board affirmed the list of schools staff is recommending for a full cap for the remainder of the 2012-13 school year with the addition of Hunter Elementary.

The Board affirmed that any reference to partial capping in the administration's proposed 2013-14 school assignment plan is subject to revision of Board Policy 6204 to authorize partial capping by the administration.

The Board affirmed the addition of a priority for non-entry grade siblings during the magnet application period.

The Board affirmed the addition of priorities for non-entry grade siblings, and for students requesting their choice plan feeder pattern middle or high school during the first transfer period.

The Board rejected the addition of a priority for students whose base school is identified as low-performing and request assignment to a school that is identified as high-performing. However, the Board agreed to have further discussion on this issue for future year consideration.

The Board requested that staff bring back the order of priorities for the first transfer period as a discussion item for their work session on December 11, 2012.

The Board directed staff to amend the administration's proposed 2013-14 school assignment plan to reflect the following:
