It is preferred that the only users who can have access to a student's record in this system is for the therapist and program level supervisors. Teachers should only have access to a general dashboard without any identifying information.
Data Portability, Page 7	What are the technical requirements for integrating with SIS, IMS, LMS and other platforms?	We do not foresee the need to integrate with our LMS or other platforms.
