Satellite site will be at a location, owned by Wake County Public School System, where there will need to be a "parts store"/counter present. Wake County Public School System will own or lease the satellite site and be responsible for the upkeep, care, and maintenance of such site. Bus landing site is where school buses are parked.
RFP Section 2, Page 7	RFP states that in the event that an employee needs to be replaced at the behest of WCPSS, it must be done so in 5 business days. Given today's tight labor market, 5 days may not be a suitable amount of time to provide an acceptable replacement. Furthermore, it is impossible to know if the job market will tighten or relax within the potential 8 year term of this contract. Would WCPSS consider amending language to read, "employee will be replaced as quickly as possible, subject to job market conditions at the time." Basically, WCPSS is only responsible for paying the lessor of (1) the cost negotiated by WCPSS directly with the specified parts supplier or (2) the cost actually paid by Provider for parts and supplies.
Warranty Records, Page 13	How are warranty records currently maintained? We ask because management of warranty by the Provider at the outset will need consideration of prior part issuance activity and access to related records.	The Provider is responsible for maintaining warranty records. WCPSS will assist with prior activity.
